The teacher's authentication adds credibility to the application and ensures that assistance is provided to students genuinely in need.
4. **Financial Assistance Disbursement:** Upon successful verification and approval of the application, financial assistance is provided to the eligible students through cheques. The amount disbursed is determined based on the assessed financial need and the availability of funds under the scheme.
5. **Guarantor:** The class teacher of the concerned class serves as the guarantor for the student availing the financial assistance. This ensures accountability and helps in monitoring the progress of the student throughout the academic year.
6. **Record Maintenance:** A comprehensive record of the financial assistance provided to students under the Vidhyadhan Kalash Yojana is maintained by the college. This record includes details such as the recipient's name, amount disbursed, date of disbursement, and any other relevant information.
