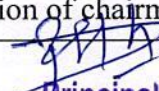
The Nineteenth IQAC meeting was held on 27th July 2023 at 5.00 p.m.

Sr. No.	Agenda	Minutes
1	Discussion on previous meeting.	IQAC Co-ordinator Asst. Prof. Sachin Pathare welcomed all the members of IQAC and read the previous meeting report on various criterias.
2	Tentative academic calendar for 2023-24.	It was decided in the meeting that the IQAC should prepare tentative academic calendar (2023-24). It should be prepared and uploaded on the college website.
3	Discussion on organizing certificate courses on communication skill and Drafting Pleadings.	The IQAC deliberated on initiating two value-added certificate courses one on Communication Skills and another on Drafting and Pleading Members unanimously agreed on the relevance of these courses in enhancing students' professional competencies. It was decided to finalize resource persons, course content, and schedules within a week, ensuring alignment with academic objectives. The timeline and mode of implementation were discussed, with a resolution to launch both courses in the upcoming semester.
4	Discussion on collection of feedback from stakeholders.	The IQAC discussed the systematic collection of feedback from all stakeholders, including students, faculty, alumni, employers, and parents, as a critical quality enhancement measure. It was resolved to design structured feedback forms tailored to each stakeholder group, focusing on curriculum relevance, teaching effectiveness and institutional support.
5	Discussion on mentoring and counselling initiatives.	The IQAC deliberated on strengthening mentoring and counselling initiatives to support students academic, personal, and professional development. It was decided to implement a structured mentoring program where faculty mentors will be assigned to small groups of students to provide guidance and address individual concerns.
6	To involve student representative as member of IQAC committee	It was decided unanimously that topper from BALLB-IV year or LLB-II year should be nominated as a member of IQAC in the beginning of each academic year.
